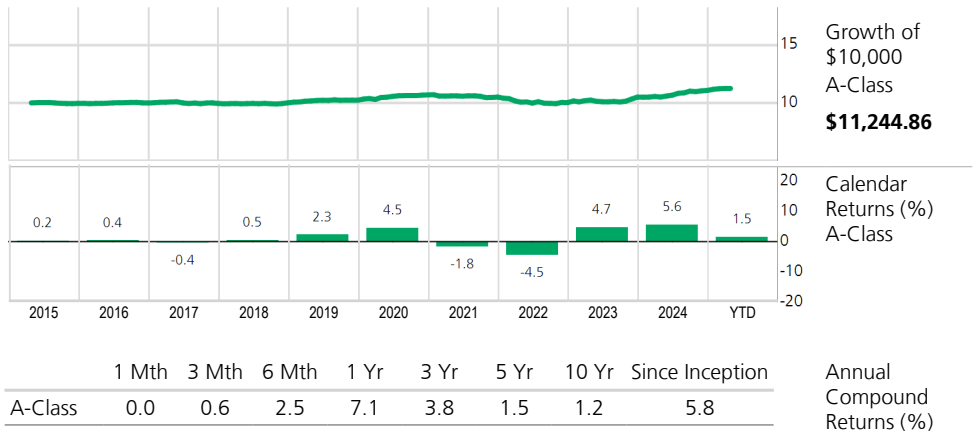

The Fund seeks to provide unitholders with a competitive and regular income primarily through investments in short-term bonds of various levels of government and high-quality companies.

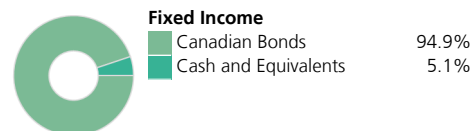

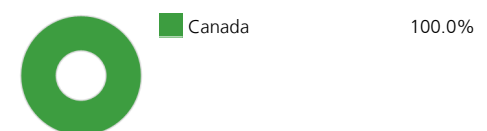
