WHAT DOES THE FUND INVEST IN?

The Fund seeks to replicate the return of the Desjardins American Equity Growth Fund (the "Underlying Fund") by investing its assets in the units of the Underlying Fund, which itself invests primarily in equity and equity-related securities of United States companies and/or units of mutual funds which themselves invest primarily in equity and equity-related securities of United States companies. On January 31, 2017, the Fund invests 99.9% of its net assets in I-Class units of Desjardins American Equity Growth Fund. The charts below give you a snapshot of the Fund's investments on January 31, 2017. The Fund's investments will change.

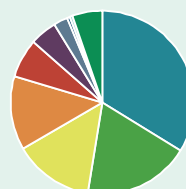

HOW RISKY IS IT?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns.

Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Desjardins Investments Inc. has rated the volatility of this Fund as **medium**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

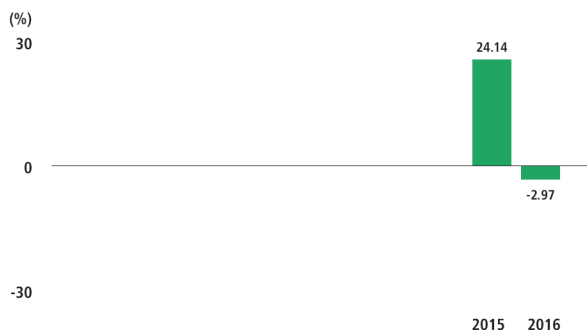

HOW HAS THE FUND PERFORMED?

This section tells you how Series A shares of the Fund have performed over the past 2 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

Year-by-year returns

This chart shows how Series A shares of the Fund performed in each of the past 2 years. On an annual basis, the value of the Fund decreased during 1 year for the period shown. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series A shares of the Fund in a 3-month period over the past 2 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

A person who invested \$1,000 in Series A shares of the Fund since its inception holds today \$1,419, which represents an annual compounded rate of return of 13.25%.

WHO IS THIS FUND FOR?

An investor who:

- is looking for long-term capital appreciation;
- wishes to add a core American equity fund to the portfolio.

! The shares of this Fund are not eligible for registered plans. The shares of this Fund are unsuitable for investors who want to invest in registered plans.

A WORD ABOUT TAX

In general, you will have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and on whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

HOW MUCH DOES IT COST?

The following tables show the fees and expenses you could pay to buy, own and sell Series A shares of the Fund. The fees and expenses — including any commissions — can vary among Series of shares of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales Charges

Series A shares of the Fund are no load. That means you pay no initial sales charge and no deferred sales charge.

2. Fund Expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

On September 30, 2016, Fund expenses represented 2.78% of its value, or \$27.80 on each \$1,000 investment.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own shares of the Fund. It is for the services and advice that your representative and its firm provide to you.

Desjardins Investments Inc. pays the trailing commission to your representative's firm. It is paid from the Fund's management fee and is based on the value of your investment.

The rate of the commission is a maximum of 1.00% of the annual value of your investment, which represents \$10.00 for every \$1,000 invested.

3. Other Fees

You may have to pay other fees when you buy, hold, switch or sell shares of the Fund.

Fee	What you pay
Short-Term Trading Fee	Up to 2% of the value of the shares you switch or sell within 90 days of purchase. These fees are paid to the Fund.

Reclassification Fee	None
Additional Fees	Please note that your representative's firm may charge additional fees. These fees might be negotiated with your representative.

WHAT IF I CHANGE MY MIND?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a Simplified Prospectus or a Fund Facts document; or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the Simplified Prospectus, Fund Facts document, Annual Information Form or Financial Statements contain misrepresentations. You must act within the time limit set by the securities law in your province or territory. For more information, see the securities law of your province or territory or ask a lawyer.
