The Fund seeks to replicate, to the extent reasonably possible and before fees and expenses, the performance of an emerging markets multifactor-controlled volatility equity index. Currently, the Fund seeks to replicate the performance of the Scientific Beta Emerging Markets Multifactor-Controlled Volatility Index, net of fees and expenses. Under normal market conditions, the Fund will primarily invest in emerging markets equity securities.
