#### Major changes to portfolio in the period

- → Broadly decreased credit risk at the portfolio level mainly through increasing the underweight to Emerging Markets as COVID-19 cases surged in many Emerging Market countries.
- → Increased exposure to high yield, especially in financials and banks, given strong balance sheet fundamentals following 10 years of capital build-up and regulatory support. Increased exposure to high yield autos as consumer demand remains strong.
